Solar Street Light Project:

Intending to promote sustainability and make the city a greener urban space, Annapurna decided to take a step towards reducing carbon footprints and encouraging the use of renewable and sustainable energy sources. The strategy involved the installation of solar streetlights, aiming to replace conventional electric ones with eco-friendly alternatives. The CSR team identified poorly lit zones within Bhubaneswar and commenced negotiations with the BMC to obtain approval for the installation process. As of April 1st,



2024, the organization has effectively implemented 60 solar streetlights across Sailashree Vihar, Kedar Gouri Temple, Gayatri Slum, and other prime locations in Bhubaneswar.

In February 2024, a stakeholder consultation on Environmental, Social, and Governance (ESG) matters was conducted by the consulting partner Care Edge.
